Purpose of the Committee: The purpose of the committee is to study local library service, the options, the needs and the funding.

The 1993-94 Iowa County Library Planning Committee met at the Cobb Public Library September 13, 1994 at 6:30 P.M.

Chairperson, Lois Menninga, called the meeting to order at 6:30 P.M. Victoria Kolb. Secretary, called the roll. Committee members present: Joan Mish, Victoria Kolb. Earlene O'Keefe, Mary Lou Fry, Valerie Foley, Inez Learn, Lois Menninga, Cheryl Lemanski, Therese McCarragher and LaVerne Draves. Absent: Thomas Kelly, Peter Press.

Lois Menninga announced that the meeting had been duly posted and was certified as an open meeting. Joan Mish made a motion to approve the agenda. Therese McCarragher seconded the motion. Motion carried.

Correction to the minutes: Lois Menninga and Earlene O'Keefe were added to the staffing schedule of the Bookmobile at the County Fair on Saturday, Sept. 3 from 4 p.m. to 7 p.m. Mary Lou Frey moved that the minutes be approved as corrected. Cheryl Lemanski seconded the motion. Motion carried.

Suggestions for next year included: 1) Be a part of the "On-Stage" presentation where the Icwa County Library Committee could use the amount of allotted time to promote libraries. 2) Honor outstanding

summer library program participants. 3) Put on a playlet such as Jym Wroblewski of SWLS has done.
