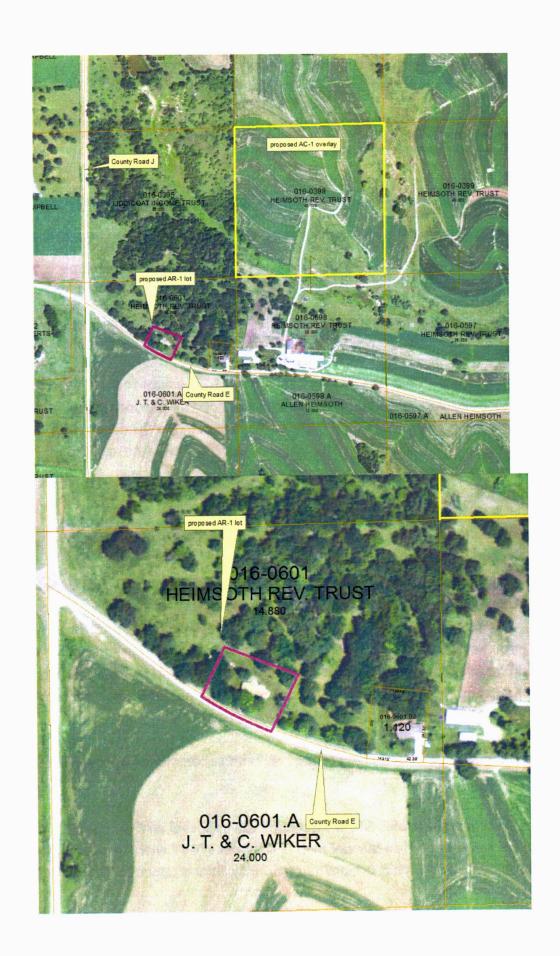
Petition Summary: This is a request to rezone 1.25 acres from A-1 Agricultural to AR-1 Agricultural Residential for the purpose of dividing the residence from the farm. The request includes zoning 40 acres with the AC-1 Ag Conservancy to comply with rural residential density standards.

Comments/Recommendations

- 1. The minimum lot size to remain A-1 Ag is 40 acres, thus the request to rezone to AR-1 Ag Res.
- 2. If approved, the AR-1 district allows one single-family residence and accessory structures, which exist on the proposed lot.
- 3. The associated preliminary certified survey map has been submitted for review.
- 4. The proposal is consistent with the town and county comprehensive plans as it would preserve 40 acres for agricultural uses and not convert any agricultural land to other uses.

Town Recommendation: The Town of Mifflin recommends approval of the request as presented.

Staff Recommendation: Staff recommends approval with the condition that the associated certified survey map is duly recorded with the Iowa County Register of Deeds within 6 months of County Board approval of the rezoning
