

Petition Summary: This is a request to create 5 residential lots by rezoning from A-1 Ag & AR-1 Ag Res to all AR-1 Ag Res. The proposed lots are 10.45, 5.25, 5.09, 5.86 & 5.0 acres



#### Comments/Recommendations

1. Currently, the property consists of one 17.01-acre legal nonconforming A-1 lot and one 15.7-acre AR-1 Ag Res lot.



- 2. If approved, each of the proposed lots will be eligible for one single-family residence, accessory structures and limited agricultural uses. The proposed 5.0-acre lot has an existing residence.
- 3. There are two associated certified survey maps under review.
- 4. The proposal is consistent with the town and county comprehensive plans as it would not convert any existing agricultural land to other uses.

**Town Recommendation**: The Town of Brigham recommends approval. **Staff Recommendation**: Staff recommends approval with the condition that the associated certified survey maps are duly recorded with the Register of Deeds within 6 months of the County Board approving the rezoning.
