Petition Summary: This is a request to divide an existing AR-1 Ag Res lot and rezone 17.654 acres to C-1 Conservancy. 5.424 acres will remain AR-1.

Comments/Recommendations

- 1. This proposal involves the applicant proposing to sell the 17.654 acres to an adjacent landowner who owns land to the north and to the east in Dane County.
- 2. If approved, the remaining 5.424-acre AR-1 lot would include the existing residence. The C-1 district would allow open space uses and prohibit any structures that require a zoning permit.
- 3. The proposed C-1 lot is mostly mapped as floodplain and includes significant wetlands.
- 4. The associated preliminary certified survey map has been submitted for review.
- 5. The C-1 lot will include about 0.11 acre of land owned by the Doeschers to the north.
- 6. The proposal is consistent with the town and county comprehensive plans as it would not convert any existing agricultural land to other uses and preserve 17.654 acres from development.

Town Recommendation: The Town of Arena recommends approval.

Staff Recommendation: Staff recommends approval with the condition that the associated certified survey map is duly recorded with the Iowa County Register of Deeds within 6 months of County

Board approval of the rezoning.
