

Petition Summary: This is a request to rezone 28.629 acres from AR-1 Ag Res & A-1 Ag to all AR-1 Ag Res. The purpose is to enlarge the existing AR-1 lot.

Comments/Recommendations

- 1. If approved, the lot would be eligible for one single family residence, accessory structures which already exist.
- 2. If approved, the balance of the Neumaier property will need to be combined by deed in order to achieve contiguity and comply with minimum lot sizes. This is the intent of the applicants.




- 3. The associated certified survey map has been submitted for review.
- 4. The proposal is consistent with the town and county comprehensive plans as the area to be zoned from A-1 is not productive farmland.

Town Recommendation: The Town of Arena recommends approval.
