
### Comments/Recommendations

- 1. The A-1 district requires a minimum 40-acre lot size. Delbert intends to transfer the balance of his property (38.5+ acres) to Patrick and keep the 2.3 acres with house.
- 2. The associated certified survey map for the 2.3 acres has not yet been submitted for formal review.
- The proposal is consistent with the town and county comprehensive plans as it would not convert any existing agricultural land to other uses.
