Petition Summary: This is a request to rezone 3.853 acres from A-1 Agricultural to AR-1 Agricultural Residential in order to separate and sell from the parent farm. 32.394 acres would have the AC-1 Ag Conservancy overly imposed to comply with the town/county residential density for the Town of Dodgeville.

#### Comments/Recommendations

- 1. The A-1 district requires a minimum 40-acre lot size. The intent is to separate the house and accessory buildings from the farm. About 91 acres will remain of the parent farm.
- 2. The associated certified survey map is under review.
- The proposal is consistent with the town and county comprehensive plans as it would not convert any existing agricultural land to other uses and preserve over 32 acres of productive farmland from development.

**Town Recommendation**: The Town of Dodgeville recommends approval including the AC-1 overlay

Staff Recommendation: Staff recommends approval with the condition that the associated certified survey map is duly recorded with the Iowa County Register of Deeds within 6 months of County Board approval of the rezoning.
