

#### Comments/Recommendations

- 1. If approved, the proposed lot would be eligible for one single-family residence, accessory structures and limited agricultural uses.
- 2. The associated certified survey map is under review.
- 3. The 1958 soil survey classifies the soil of the lot to be Class II. The soil test for the septic site shows 52-54 inches of good soil.
- 4. In order to be consistent with the town and county plans, the following land use policy needs to be addressed: Protect active agricultural lands from encroachment by incompatible uses.

Town Recommendation: The Town of Highland recommends approval. Staff Recommendation: Staff recommends approval if deemed consistent with the plan policy and that the condition that the associated certified survey maps are duly recorded with the Register of Deeds within 6 months of the County Board approving the rezoning.
