Petition Summary: This is a request to rezone 10.13 acres from A-1 Ag to AR-1 Ag Res in order to create residential lot on which an existing residence is located and sell the remainder of the parent farm to an adjoining landowner.

Comments/Recommendations

- 1. If approved, the proposed lot would be eligible for one single-family residence, accessory structures and limited agricultural uses. A residence exists on the proposed lot.
- 2. The associated certified survey map is under review.
- 3. The balance of the existing farm...approximately 30 acres...will need to be combined by deed with the adjoining landowner's property to meet county zoning and land division requirements.
- 4. The proposal is consistent with the county and town plans it would not convert existing ag uses to another use.
