Petition Summary: This is a request to rezone an existing 39.67-acre nonconforming A-1 Ag lot to AR-1 Ag Res in order to make it a lot eligible for development

Comments/Recommendations

- 1. The lot is currently nonconforming as it is less than the required minimum 40 acres for the A-1 district and was created after this requirement was enacted.
- 2. If approved, the AR-1 district allows for one single-family residence, accessory structures and some agricultural uses.
- 3. The associated preliminary certified survey map has been submitted for review.
- 4. The proposal is consistent with the town and county comprehensive plans as it would not convert any existing agricultural land to other uses. The property is primarily wooded as is the land surrounding it.

Town Recommendation: The Town of Linden recommends approval.

Staff Recommendation: Staff recommends approval with the condition that the associated certified survey map is duly recorded with the Iowa County Register of Deeds within 6 months of County Board approval of the rezoning.
