

RESOLUTION # 5-1215

CARRYOVER OF CERTAIN ACCOUNTS

WHEREAS, certain departments desire to carry over revenues or unused levy dollars from the 2015 budget for use in 2016 in an amount to be determined upon closing the 2015 books; and

WHEREAS, the use of certain revenues is limited by externally enforceable constraints; and

WHEREAS, the Administrative Services Committee has reviewed these requests as required by the Iowa County Carryover Funds Policy dated December 15, 2015,




