And, this petition is made to zone 5 acres from A-1 Agricultural to AR-1 Agricultural Residential;

Whereas notice of such petition has been properly advertised and notice has been given to the **Clerk of the Town of Moscow** and the Town is recommending approval as it has been deemed to be consistent with the goals and intent of its adopted comprehensive plan;

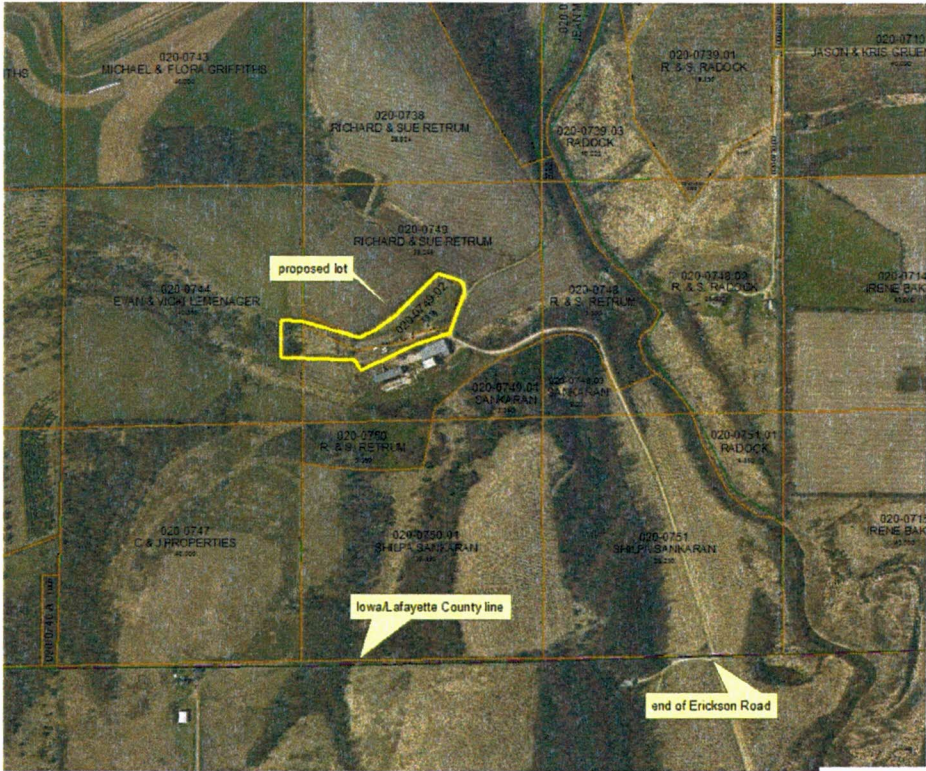
Petition Summary: This is a request to rezone 5 acres from A-1 Ag to AR-1 Ag Res to create a residential lot.

Comments/Recommendations

1. The proposed AR-1 lot would allow one single family residence, outbuildings and limited ag uses. There is an existing residence on the 5 acres.
2. The associated certified survey map has yet to be submitted for formal review.
3. The proposal is consistent with the town and county plans as it is not converting productive ag land to other uses.

Town Recommendation: The Town of Moscow recommends approval.

Staff Recommendation: Staff recommends with the condition that the associated certified survey map is duly recorded within 6 months of zoning approval by the County Board.


