

Petition Summary: This is a request to rezone 5 acres from A-1 Ag to AR-1 Ag Res to create a residential lot.

Comments/Recommendations

- The proposed AR-1 lot would allow one single family residence, outbuildings and limited ag uses. There is an existing residence on the 5 acres.
- The associated certified survey map has yet to be submitted for formal review.
