375.04 Animal at Large

**375.05** Habitual Bark

375.06 Animal Waste

375.07 Animal Care

375.08 Quarantine

375.09 Livestock at Large

**375.10** Failure to Obtain a Permit

**375.11** Licensing Required-Pat-bellied Pigs

375.12 Failure to Obtain Exotic Animal Permit

**375.13** Inspection Required-Circuses and Theatrical Exhibitions

**375.14** Disposition of Carcasses

**Now Therefore Be It Resolved** that the lowa County Board of Supervisors do hereby adopt this resolution setting the schedule of forfeitures for violations as follows associated with the Animal Control Ordinance to be effective February 1,2010:

<u>375.02</u>	Forfeiture of not more than five hundred dollars (\$500.00) plus costs
<u>375.03</u>	Forfeiture of not more than five hundred dollars (\$500.00) plus costs
<u>375.04</u>	1st Offense - forfeiture not more than one hundred dollars (\$100.00) plus costs
	2nd and subsequent - forfeiture of not more than two hundred dollars (\$200.00) plus costs
<u>375.05</u>	Forfeiture of not more than two hundred dollars (\$200.00) plus costs
<u>375.06</u>	Forfeiture of not more than two hundred dollars (\$200.00) plus costs

<u>375.07</u>	Forfeiture of not more than five hundred dollars (\$500.00) plus costs
<u>375.08</u>	Forfeiture of not more than one thousand dollars (\$1000.00) plus costs
<u>375.09</u>	1st offense - forfeiture of one hundred dollars(\$100.00) per animal plus costs
	2nd and subsequent offenses - forfeiture of two hundred dollars (\$200.00) per animal plus costs
<u>375.10</u>	Forfeiture of one hundred dollars (\$100.00) plus costs
<u>375.11</u>	Forfeiture of not more than five hundred dollars (\$500.00) plus costs
<u>375.12</u>	Forfeiture of not more than five hundred dollars (\$500.00) plus costs
<u>375.13</u>	Forfeiture of not more than one hundred dollars (\$100.00) plus costs
<u>375.14</u>	1st offense - forfeiture of not more than two hundred fifty dollars (\$250.00) plus costs
	2nd and subsequent offense-forfeiture of not more than five hundred dollars (\$500,00) plus costs
