
We, the Iowa County Committee on Salary and Personnel, do hereby recommend that management salaries for 1996 be as follows:

We, further recommend amending Part VI, Section H-Retirement of the Iowa County Personnel Policies as follows: "The County hereby agrees to pay on behalf of the employee, to the Wisconsin Retirement Fund, the employee's contribution, not to exceed six and five-tenths percent (6.5%) (presently 6.2%) of their gross wages." We further recommend amending Part VI, Section A-Vacation to "Employee will be allowed to use earned vacation with pay of no less than one (1) hour (presently one-half day) increments."
