Dodgeville, WI— March 19, 2020—lowa County Public Health continues to manage local efforts collaborating with Iowa County Emergency Management, Upland Hills Health Hospital & Clinics, Local School Districts, Iowa County Public Safety Agencies, and other partners to plan, prepare and respond together as a community. As we continue efforts to limit and slow the spread of this disease, we are urging **all residents of Iowa County please help in our response**. We want to reinforce the importance of assisting in carrying out the latest recommendations to remain at home unless you need to leave for essential reasons. Taking these actions not only protects yourself, but those you love and the broader community. Sharing accurate information with neighbors, friends and co-workers, especially people who may have difficulty receiving or understanding the information is an important role you can play. Please continue to stay up-to-date on current case counts and recommendations by visiting the resources listed below.

Public Health urges residents to follow these recommendations:

- The best way to prevent COVID-19 is to prevent exposure by practicing social distancing and hand hygiene.
- Cover your coughs and sneezes using a tissue. Be sure to wash your hands with soap and water immediately afterwards and avoid touching your eyes, nose and mouth.
- Regularly clean frequently touched objects and surfaces.

- Cancel events and do not gather with others for things such as playdates. We encourage you to cancel non-essential appointments, and practice social distancing, even in small groups.
- Please do NOT go to the emergency room unless essential. Emergency rooms need to
 be able to serve those with the most critical needs. If you have symptoms like cough, fever,
 or other respiratory problems (even if you suspect COVID 19), isolate yourself and contact
 your regular medical provider first. Providers/Clinics are versed in the procedure for getting
 people tested if that is determined to be a need. At this time, individuals with mild
 symptoms are asked to PLEASE stay home and nurse your illness as you would if you had
 the flu or cold.
- If you must visit a provider, please avoid any unnecessary stops to limit exposure.
- 211 is available to answer questions regarding COVID 19, including local procedures for testing.
