Iowa County COVID 19 Response

Iowa County — We are all in the midst of unprecedented times with the COVID 19 pandemic. It has brought impactful change to our daily lives. Preparation for a pandemic, just as with other disasters, has been occurring for many years. Planning and response efforts began intensely in early March and are ongoing today and for the foreseeable future.

Many dedicated partners are involved in the response including: Iowa County Health Department, Iowa County Emergency Management, Upland Hills Hospital and Clinics, Local School Districts, Iowa County Sheriff's Department, Iowa County Public Safety Agencies, including law enforcement and first responders, the County Coroner's Office, area Funeral Directors, Long Term Care facilities, Iowa County Government and Facility Services, Unified Counseling, Social Services, ADRC, SUN Program and many others. The Iowa County Emergency Operations Center was officially operational on March 12th, 2020 and has been functional 24/7 each day since. Operations in the Iocal EOC involves daily briefings, virtual meetings and planning with several partners such as the State EOC, Upland Hills, public health partner briefings, statewide meetings with statewide agencies such as DHS, regional planning meetings, weekly stakeholder meetings with broad community partners, etc.

Each day of the response has consisted of planning around the broad topic areas of Health Care System Planning and Response, Personal Protective Equipment, Testing, Elections, Public Information and Messaging, Case Investigation and Contact Tracing, Community Mitigation, Daily Operations including Building Capacity to Respond, Long Term Care, Mental Health, Vulnerable Populations, and Business/Organizations.

Our mission remains the goal of limiting and slowing the spread of this disease in order to flatten the curve and maintain sufficient capacity in our hospitals to care for those that need it. The response requires partnership between so many in health care, government and the private sector but the most important partner is the public. We recognize the sacrifice being made and know it is difficult. We ask that you continue to rise to the challenge and protect your family friends and neighbors who are vulnerable. We advise you to stay informed with reliable sources of information, take everyday actions to protect yourself and those you love, and share accurate information with neighbors, friends and co-workers, especially people who may have difficulty receiving or understanding the information. We encourage residents to continue to patronize local businesses and utilize services offered.

Our recommendations are as follows:

- Stay up-to-date on current case counts and recommendations
- The best way to prevent COVID-19 is to prevent exposure to people outside your household.
- Cover your coughs and sneezes using a tissue. Be sure to wash your hands with soap and water immediately afterwards. Consider wearing a cloth face covering while in public.
- Avoid touching your eyes, nose and mouth.
- Regularly clean frequently touched objects and surfaces. Make sure to clean high-touch surfaces like counters,

tabletops, doorknobs, bathroom fixtures, toilets, phones, keyboards, tablets, and bedside tables.

- Stay home if able, avoid group gatherings, and practice social distancing.
- Stay home when you are sick
- If you are having symptoms or you have questions, please contact your regular medical provider. Providers/Clinics are versed in the procedure for getting people tested if that is determined to be a need.

We also encourage businesses, organizations, cities, villages and all stakeholders make a plan – how will you ensure social distancing and protect those who are part of your team? What modifications in work space or work flow will you need to make. What will it take to get you there?
