Patience Needed with COVID-19 Vaccine Roll Out

Iowa County – The Iowa County Health Department, Iowa County Emergency Management and Public Safety agencies continue efforts to administer COVID-19 vaccine to individuals who meet the criteria for Phase 1A. Currently, frontline health care workers, residents in long-term care facilities (nursing homes and assisted living facilities), law enforcement, EMS, corrections officers and fire personnel are still being vaccinated in Iowa County.

We understand people are eager to get immunized and have questions about when they will be able to do so.

Patience is the primary need at this time, as the Wisconsin Department of Health Services (DHS) released that adults over the age of 65 will be eligible to receive starting January 25. The Health Department and Emergency Management as well as area hospitals, healthcare providers and pharmacies are preparing for the next phases of COVID-19 vaccinations.

Locally, the Iowa County Health Department and Upland Hills Health plan to begin vaccinations for 65+ after 1/25/2021. This is subject to vaccine availability.

Vaccine quantities are limited. Expect your appointment to be scheduled at a future date as we work to vaccinate our populations as quickly as we have vaccine to do so. Once again, we ask for your patience and understanding in this process. Our goal is to ensure everyone in Iowa County is vaccinated as soon as possible.
