Miscellaneous uses and activities requiring regular zoning permit but with no establishment or conversion of structure	150.00
Miscellaneous uses and activities requiring regular zoning permit but with no measurable footprint (e.g., structural alterations/repairs)	75.00
Structure not defined as a building (e.g., swimming pool, bins, tanks, open deck, etc.)	75.00

<p>AFTER THE FACT FEES: <i>The following fees apply for construction begun before a required permit is secured:</i></p> <p>First Offense: triple the regular fee Second Offense: quadruple the regular fee Third Offense: quadruple the regular fee plus citation</p> <p>Each offense is exonerated if, after 36 months, there have been no subsequent offenses by the property owner. These fees pertain to the property owner regardless whether the affected property is the same from one offense to another.</p> <p><i>NOTE:</i> <i>In the case of rebuilding after a natural disaster, an appeal may be made to the Iowa County Planning & Zoning Committee for a fee reduction or waiver.</i></p> <p><i>NOTE:</i> <i>All development is also subject to county and/or state permit requirements if in the floodplain, shoreland or airport zoning jurisdictions. Local permits may be required under the Uniform Dwelling Code. Please contact this office to verify.</i></p>

Digital Data Fees:

*****Note: All requests shall be distributed in the form in which they exist. A \$50 conversion fee will be charged to convert the data to other systems or coordinates.**

First datalayer	\$500 countywide	\$100per town
Each additional datalayer	\$250 countywide	\$50 per town
Orthophotography	\$500 countywide	\$200 for first tile plus \$50 for each additional orthophotography tile

Hard Copy Fees:

Any request which involves special processing versus simple duplication, shall be charged at the following rate:

- \$40.00 set-up fee (this covers up to one hour of processing time) requests that take more than one hour to complete will be charged \$10.00 for each additional 15 minutes, or any fraction thereof, in addition to the set-up fee.

Any request that involves only duplication of existing data shall be charged the cost of duplication at the following rate:

- \$10.00 for every 15 minutes of processing time, or any fraction thereof plus the cost of media, postage, and shipping
